

ISCA General Assembly 2019 Minutes

The 23rd ISCA General Assembly was held in Budapest, Hungary on October 19, 2019.

1. Opening and welcome by the President of ISCA, Mogens Kirkeby

Mogens Kirkeby welcomed new and old delegates and referred them to the official 2019 <u>Delegate</u> <u>File</u> which will feature most of the subjects. A special welcome to Jean-Claude Besnard, who has been with ISCA since its founding, was extended, followed by a round of applause.



2. Election of two chairpersons for the General Assembly

The Executive Committee (hereafter ExCo) nominated two chairpersons for the GA: Laura-Maria Tiidla from ISCA secretariat and Eduardo Uhle from SESC, Brazil. The chairpersons were appointed with a round of applause.

3. Adoption of the Agenda

The chairpersons welcomed all the participants that were present. The chairpersons explained the rules for voting and proposed the agenda for the General Assembly. Each represented member had one vote.

In addition, chairpersons introduced three additional ISCA secretariat members:

- Emma Venneker who will take notes
- Maja Thormar and Marie Oleinik who will count the votes.

The chairpersons suggested to swap topic 9 to 10, therefore having proposals before the elections. **20 votes for, 0 against, 1 not voting – accepted.**

The General Assembly agenda was put to vote and was adopted by all member organisations present.

The chairpersons explained that there are two groups indicated in the delegate file: organisations who applied and were confirmed by ExCo, latest on the meeting that took place in June, and organisations who applied between June ExCo meeting and the last one. The latter group were endorsed by the Executive Committee on their short meeting three days ago.

The chairpersons proposed to adopt all organisations as a full package if there were no comments. All who voted were in favour of adopting the full list of proposed members.

Since NSULF and Basketball Association of the Philippines were present at the GA, their delegates received voting rights for the rest of the GA.

6. Report by president Mogens Kirkeby

ISCA president Mogens Kirkeby presented his report of the year, consisting of the following points:

- Descriptions of the projects, in particular Grassroots Sports Diplomacy, MOVE Transfer EU-China, No Elevators Day, European School Sport Day, Open Streets Day.

- Overview of future action plans, external and internal
- A little exercise
- Future actions plans in the context of SDGs

- Special mentioning of Detlef Mann (DTB), who for personal reasons has decided not to go for re-election as an ISCA ExCo member, and Philippe Machu who in spring 2018 stepped down as the president of UFOLEP (France) and has decided not to go for re-election as an ISCA ExCo member.

The president's report for put up for adoption with 22 votes "for", 0 "against" and 1 not voting. The report has been accepted.

7. Committee and Network Reports

In addition to the reports presented in the Delegate File pages 17-29, ISCA Latin America activities were presented by Maria Luiza Souza Dias.

8. Report of secretary general Jacob Schouenborg

Jacob Schouenborg, ISCA General Secretary gave report to General Assembly about ISCA activities in 2018-2019, as well as some plans for 2020.

Shortly put, he felt confident about current status and elaborated on the following points:

- Role of ISCA
- Grassroots Sport Diplomacy
- Physical Literacy bodily confidence should be a part of everybody's life and wellbeing.
- Understanding each other through the concept of SDGs
- EU-China opening new doors in Asia
- OSD, IRTS, ESSD, MoveWeek, Online Learning testing to understand new trends.

Next, the Secretary General gave an overview of ISCA accounts. 76% of turnover is generated through externally-funded projects.

In 2017, the result was slightly negative but almost balanced. In 2018, a 1.5 million EUR turnover was generated due to externally-funded projects with a surplus of 45 000 EUR.

The Secretary General pointed out that there is at the current moment a projected lower turnover in the next 2 years, however the fundraising work will continue and is expected to alter that. After presenting the budget for the next two years, as adopted by the Executive Committee, the chairpersons proposed to put the ISCA budget for adoption.

At that point, Bilyana Mileva (BG BeActive, Bulgaria) had joined the GA, making the total number of voting members 24.



Budget for adoption: 24 votes "for", 0 votes "against. Accepted.

ISCA's auditor was proposed to remain Buus Jensen. ISCA has been using their services for a few years and are satisfied with the service and prices. 24 votes "for", 0 votes "against". Accepted.

9. Proposals

- The Executive Committee proposes changes of ISCA Statutes specifying the Secretary General as legal representative (page 11 in the Delegate File). In order for the proposal to be adopted, a minimum of 51% votes in favour are required. 24 votes "for", 0 "against". Proposal accepted.
- 2. The Executive Committee proposes to initiate an open and transparent process of preparing a new ISCA Strategy following the current Strategy 2018-2021 (page 13 in the Delegate File).

23 votes "for", 0 "against", 1 not voting. Proposal accepted.

3. Reformulation of ISCA membership (page 14 in the Delegate File). It has been suggested to remain with the current membership fee for the next 2 years but continue developing the new membership structure for presentation at the next General Assembly in 2021. In the meantime, the new membership offer may be tested among new and old members.

The new visual identity was presented at this point, featuring the new logo and mascot. The new website url will be isca.org.

The proposal was put up for adoption in 2 parts.

- 1) Maintain the current membership structure for 2 years, while testing a new model: 22 votes "for", 0 "against", 2 not voting. Proposal accepted.
- New membership structure to be presented for adoption at the next GA in 2021: 24 votes "for", 0 against. Proposal accepted.

10. Elections

Presentations of the nominated candidates are found at ISCA website.

In accordance with Articles 5.3 and 7.16 of the statutes, the General Assembly shall elect representatives to the posts of President (1), Vice Presidents (2) and members of the Executive Committee (5).

Chairpersons referred to Article 7.9 of the statutes which stipulates that nominations were to be received by 7th September 2019.

For the ISCA president position only one nomination was submitted – Mogens Kirkeby.



For the two Vice President positions, Toni Padilla Llop and Maria Luiza Souza Dias were nominated.

For the ExCo, by the 7th of September, six nominations were submitted, namely Liliana Ortiz, Jakub Kalinowski, Branko Vujovic, Carlo Balestri, Arnaud Jean and Michael Tiemann.

Before the elections had begun, Maja Thormar from ISCA invited the participants to join her in an energiser exercise.

The nominees had the opportunity to make a short presentation/speech before the voting.

The voting took place in 2 rounds
