**ENGSO** Manifesto on a Truly Inclusive Sport

- Adopted by the ENGSO General Assembly in 2010
- Objective: Raise awareness and impact relevant policies of sport organisations
- Target groups: Sport organisations, public authorities (EU, national governments etc.)
- Eight themes:
  - 1) inclusion of immigrant populations 2) social exclusion 3) solidarity between generations 4) gender equality 5) racism 6) sexual orientation 7) violence 8) disability

# **Expected outputs**

- Social inclusion as a central theme is included in the policies and programmes of national sport organisations and concrete actions are taken on grassroots level in more and more European countries.
- A booklet of good practice on social inclusion of immigrants and people of a foreign origin in national sports organisations has been produced in order to ensure the sustainability of the project, to support the analysis based on the project, and to support further actions of organisations working in the field.
- **Policy recommendations** on social inclusion to decision-makers have been drafted and presented.
- **Analytical framework** on the key elements which should be taken into account in social inclusion in sport

# Actions

- **Bilateral study visits** between two partner organisations, each hosting one and each taking part in one
- Conferences bringing together the project partners to exchange information and experiences
- **Production of material** book of best practice, website
- **Drafting of policy recommendations** to decision-makers
- **Evaluation and analysis** key elements to be taken into account when implementing best practice examples elsewhere; evaluation of project
