

Introduction by ISCA President, Mogens Kirkeby

Dear Friends,

Welcome to the ISCA General Assembly 2008 and to the 2nd European Sport for All Congress, "*Sport and Health – from theory to practice".*

The ISCA General Assembly is the highest authority of our organisation. It is the meeting where we report on the latest developments and decide the future priorities for ISCA.

This year the Executive Committee will propose a new structure for our work. It is an open structure of thematic networks and we believe that it will definitely increase the international cooperation between the ISCA members.

The Executive Committee will also illustrate and discuss how we utilize our many external relations to promote sport for recreation, sport for the joy of life, sport for health, sport for children, sport for active seniors – in other words, "Sport for All".

We will propose that we send a Sport for All political message from the ISCA General Assembly 2008 to the sport sector and to the ministries and public institutions which are governing sport. We believe that Sport for All needs a strong and promoting voice - today and in the challenging future.

Challenges facing societies

As an integrated part of civil society and the life of citizens, our work is strongly connected to and affected by global, national and local challenges. In the same way the focus and the priorities of Sport for All organisations should mirror and react to the current challenges facing society. Societies around the world naturally face different challenges, but the past years and especially recent months have shown us that in a world ruled by globalization, the challenges have also become global.

Economic stagnation

At this moment many countries in the world are facing economic stagnation. In many countries we will not see more resources allocated to sports in total, given the current







situation marked by an economic downturn. The result in many countries will be that Sport for All will come under economic pressure. In an Olympic year with a huge amount of attention on elite sport, the risk is that resources will be taken from Sport for All activities and given to the elite sport sector. This without taking into account the impact it will have on citizens' access to sport at the local level. That could easily happen, if we do not make a clear case to the political decision makers. Sport for All produces human capital. It is not about winning medals - it is about creating better and healthier societies.

Health – public health, our lives.

Public health has become prominent on the political agenda in the past few years and will continue to constitute a huge national and international challenge in the years to come. Sedentary lifestyles, physical inactivity and obesity are some of the obstacles on the "healthy road of life". For individuals and for nations this health challenge has a huge impact, both socially and financially. Sport and its widespread organisational structure provide one of the important settings, where people can be reached, motivated and assisted to improve their lifestyle and personal health. Governments and the sectors responsible for health promotion and prevention are often not themselves able to reach the citizens and to motivate them to healthier lifestyles. This is where the Sport for All sector has a valuable structure to offer citizens, local communities and states. This unique value of the sport organisations is ready to be "cashed-in" through quality programmes and activities.

Ageing populations

Another global challenge is the demographic changes, which result in ageing populations. The average age is increasing and the number of senior citizens is growing. This presents civil society and the Sport for All organisations with new challenges. The number of senior citizens is growing and this group is much more physically active than just a decade ago. It confronts the Sport for All organisations with the challenge of providing quality activities that can attract this age group – before the private market does it! Are you ready to face this challenge from the active seniors – both in terms of offering activities and programmes as well as handling the effect that a stronger senior focus will have on sport organisations – which traditionally have had a clear "youth oriented profile".

Integration and intercultural dialogue

One of the most direct results of globalization is the movement of people across borders and between cultures. Moving to discover a new opportunity or moving in order to escape from disasters and conflicts has always been a part of world history. Today, unfortunately it is mostly seen as a short-term challenge more than a long-term advantage. A challenge which demands improved intercultural dialogue. This year is the European Year of Intercultural







Dialogue. Within the 27 countries of the European Union a net immigration of around 1 million people per year during the next 20 years have been estimated. From a political point of view sport, in terms of its structures and settings, is often referred to and preferred as an important solution to the major challenge of creating intercultural dialogue in societies. However, the popularity and the preferences for using sport in this context is not always enough to secure successful interventions and results. Commitment and quality intervention are a necessity to succeed.

The challenge of environment and climate changes

We share it and it really is a global challenge: the future climate changes and its consequences. By now, it is maybe not perceived as one of the most important issues for our organisation, but issues of great concern for citizens in general will also be a concern for civil society and its organisations. And whether it is a desire for environmentally friendly sports facilities or events, we can foresee a demand to react— either from the political level or directly from our "customers" - and should therefore be able to respond to it.

Part of the game – part of the solution

Civil society organisations are not supposed to or expected to solve all these global and national challenges. No one expects that. However, being active in and a part of civil society, it is necessary to make your position clear. The future for Sport for All organisations is challenging. Development is a tool, and clarification of the position of Sport for All organisations is a must.

We believe, that one way to achieve this is national development through international cooperation.

We are looking forward to our discussion and decisions at the ISCA General Assembly 2008.

European Continental Committee report

The current ISCA European Continental Committee (ECC) was elected in 2004 at the General Assembly in Copenhagen and has been acting continuously with the following members: Alberto Antas de Barros – INATEL, Portugal Jean Claude Besnard – UFOLEP, France Herbert Hartmann – DTB, Germany (Chairman) Rado Svetek – SUS, Slovenia Massimo Tossini – UISP, Italy Dick Wijte – NKS, Netherlands Millar Stoddard – SALSC, Scotland (Associated Member) Mogens Kirkeby – ISCA, Secretary General (until 2007) Jacob Schouenborg, ISCA, Secretary General (2008)

ISCA-Europe cross-border activities in good progress!

Since my last report about our activities presented at the General Assembly 2007 in Kuala Lumpur, Malaysia the ECC has had one meeting. It was organised by our member INATEL (Portugal) in Albufeira on April 18-20, 2008. The fact that we met only once this year may give the impression that the EEC and its members have not been very active in developing European matters of Sport for All. However, we can claim that plenty of important events and incidents took place this year within the European ISCA members as well as in regard to transnational exchange.

ECC members were able to take part actively on different occasions and at the meeting in Albufeira reported about impressive progress in various processes of development, either in regard to their level of recognition in sports policy, structural improvements or about the engagement in thematic programmes and projects. It was clear that most of the topics and priorities, which had been identified first by the ECC in previous meetings and documented within the "ISCA Social Agenda" and in the paper "*ISCA working methods and processes*" (passed by the General Assembly 2007), had met with a good response in our European ISCA members. Let me mention a few examples. Under the leadership of UFOLEP the "Environment Network" has started its activities. The "ISCA Health Network", which was







prepared by the ECC chairman and a small working group, will be launched during the General Assembly 2008 in Barcelona. The health related PATHE-project, which includes more than 20 European ISCA members, has now begun its activities. ECC member Jean Claude Besnard (UFOLEP) has assumed responsibility for further development of the "Active Seniors" programme with the aim to create a network for this area as well. Some European initiatives regarding the target group of children also deserve mentioning. One of the last important events was the international seminar on "Children's Fitness", hosted by DGI in September 2008. The topic of "Social Integration through Sport and Intercultural Dialogue" also ranked high on the agenda of European ISCA members and was dealt with through transnational exchange. A mayor highlight here was of course the International Round Table "Sport for All as the Element of Intercultural Dialogue through Sport", hosted by Sports Union of Slovenia in Ljubljana (May 2008).

Many more national, cross-border and transnational events in regard to our Sport for All development initiatives could be identified. I've mentioned only some exemplary ones, to give an idea of how active, innovative and progressive European ISCA members are going to take up the challenges for the future development of Sport for All in Europe. Transnational cooperation and networking seem to become more and more relevant for our ISCA European members. I am quite proud that ECC members were involved actively in this development process and gave some important input either in their home organisation or to our international work during the past 4-year term.

Differences in experience and ability to act call for joint efforts!

But we should not hide the fact that our 70 European ISCA members (in 32 countries) have not reached the same level of awareness, willingness and ability to act on the future challenges. We also regret a lack of commitment to our ISCA initiatives and measures from many of our members in Europe. Less than one quarter of our European members can be identified as members showing high or at least satisfying commitment. During these past years it has become obvious that we have too little information about the real situation, the difficulties, challenges and ideas on future planning of our members. To be able to develop matching concepts, projects and strategies, it is necessary to get a better understanding of the structure and procedures inside our member organisations. A differentiated analysis of the ISCA membership situation in Europe seems to be necessary and is recommended as a task either for a new European ISCA body or for the Executive Committee itself.

A new mission and structural changes for ISCA Europe are recommended!

During different debates the ECC has evaluated the effectiveness of its work during the past term. I already reported on this topic in my last report at the General Assembly in Kuala







Lumpur. It was also the main topic at our last ECC meeting in Albufeira. In the past term ECC was successful in identifying important topics for the Sport for All development in Europe as well as in outlining appropriate programmes to be implemented. But the committee was unable to act as a "working group" and to implement programmes or projects. For this task small working groups of experts with experience in implementation are needed. The committee and its members do not have the political mandate, power and capacity to encourage and to commit ISCA members for programmes and projects. If it is so that most of the challenging topics of today and for the near future have been identified and outlined. If it is so that the committee itself cannot implement programmers and projects. If it is so that the committee is unable to influence and to support strategic planning for development processes in substantial ways. Then we must ask ourselves the following questions: What can or should be the mission of an ECC in the future? Is the ECC still necessary? What can be an appropriate structure to represent the voice of European ISCA members in the Executive and in other ISCA bodies? During the last meeting ECC had an extensive discussion on those questions.

We decided at our last meeting, to put forward the following suggestion to ISCA's Executive Committee:

"A European Continental Committee should act again. A model should be developed, where there is an elected chairperson, and 3-5 core members (from strong committed organisations) elected or appointed for a 4-year period. This group has the strategic responsibility for the continental development. They can then co-opt further members for work on specific topics and for shorter periods of time. Extra membership is after application and only when commitment to the specific topic is clear."

This suggestion was discussed at the last Executive Meeting September 26-28, 2008 in Copenhagen. The result and the recommendation of the Executive Committee will be presented at the General Assembly in Barcelona. We hope to be able to find satisfying and progressive solutions.

At the end of our 4-year term I would like to thank all my colleagues in ECC for their substantial contribution and for our trusting co-operation. But our success and progress would not have been possible without the outstanding support from the general secretary's office and the staff in Copenhagen. Sincere thanks.

ACTIVITIES DEVELOPED FROM OCTOBER 2007 TO NOVEMBER 2008:

I. ISCA PROMOTION WITHIN LATIN AMERICA

Aiming to continue the work of promoting ISCA in Latin America, many actions were accomplished and we highlight some of them:

A) Contact with institutions in Brazil, Costa Rica, Porto Rico, Guatemala, Colombia, Belize, Chile, Honduras, Panama, Nicaragua and El Salvador. The institutions received information material and/or have expressed an interest in becoming members of ISCA. As a result of these actions three organizations became candidates for membership for consideration of the ISCA General Assembly 2008 in Barcelona:

- 1) FECERED Central American Educational Forum in Recreation, Physical Education and Sport.
- 2) FUSER Creation of Consulting Services in Physical Education and Recreation.
- 3) Universidad Alas Peruanas, PERU

B) Creation of bilingual promotional material (in Portuguese and Spanish)

- Institutional folder ISCA

C) Institutional support for the event Challenge Day 2008 on the American continent that included the participation of 22 countries and 3,482 cities, with the production of the following promotional material:

- 175,000 posters
- 124,000 folders
- 7,000 Coordinators' guide

II. EXCHANGE PROGRAM (SESC AND DGI SWIMMING)

- Visit to Brazil by two instructors from DGI Swimming, Denmark - March, 2008.

Continuity of the program, which was started in October 2007 when two SESC technicians were received by DGI.

III. SCHOLARSHIP PROGRAM (OLLERRUP AND VIBORG)

In August 16 students from Argentina, Brazil, Costa Rica, Paraguay, Peru and Uruguay were sent to Ollerrup and Viborg.

• ACTIONS IN 2008

CAMP BRAZIL 2008

October 8-12, at SESC Vertigo - Brazil.

Exploring the theme "Sport for All" the event will promote the exchange of experiences among Latin American students of physical education at the university level. It will also be a tool to make the participants aware about a more democratic way of thinking which includes a multiplier effect. 100 participants.

Program:

- Lectures

- Sport for All practice and experience: rope skipping, "capoeira", acrobatic gymnastics, open area gymnastics, indigenous games and trekking.

- Launch of the website "Virtual Forum of Sport for All"

- Workshop about how to manage blogs, forums and social networks and to encourage the participation of people in thematic communities and virtual environment.







SPORT FOR ALL VIRTUAL FORUM

SESC SP and ISCA initiative - accomplished through LAYC – to motivate youth, promote their development and increase their interest in culture and sports. It is a bilingual website – in Portuguese and Spanish – which is developed in a cooperative environment with the theme Sport for All. It seeks to:

- Promote debates related to sport as a mean of social inclusion and educational tool;

- Facilitate the exchange of experiences and knowledge among young people of several Latin American countries and promote the concept and principles that guide " Sport for All".

VI. COLOMBIA SUMMER FESTIVAL

ISCA CULTURAL EXCHANGE – COLOMBIA – BRAZIL – DENMARK (part of this program was promoted by the city of Bogotá)

Accomplished on August 7-18, 2008.

IX. 10th BRAZILIAN CONVENTION OF JUGGLING AND CIRCUS – October 30- 31/ November 1 and 2, 2008 – UNICAMP – CAMPINAS/SP – BRAZIL.

Partnership: ISCA

The Brazilian Convention of Juggling and Circus (CBMC) has become one of the most important events to promote circus activities and the skills of juggling in Brazil. This event includes presentations, exercises, competition, workshops and a parade around the city. It is also a place where information, contact, amusement and gathering are promoted to supplement the technical development and training.

After nine editions the CBMC has now become the biggest and most recognized juggling event in the country with the participation of hundreds of artists and enthusiasts from all over Brazil and many other Latin American countries.







Asian Continental Committee report

Last year we were given the honour to host the ISCA General Assembly and ISCA World Congress, 2007 on October 25-28 in Kuala Lumpur, Malaysia.

Even though it was hard work to co-ordinate and organize the two events with the cooperation and support from ISCA and the Ministry of Youth and Sports of Malaysia, we were able to organize the events successfully.

The ISCA General Assembly was a great success and also created history with the election of Morgens Kirkeby as the new President of ISCA. Anders Bülow, the former President stepped down as ISCA President after ten eventful years.

The ISCA World Congress 2007 with the overall theme "Get Fit, Healthy and United" was also a great success with many scientific and educational papers presented.

The principal objective of the ISCA Asian Continental Commission is to promote the values of ISCA, increase its membership and create awareness among its members about the fact that valuable opportunities and benefits in sports and culture can be obtained through ISCA's international network.

The activities of ISCA Asia is focused on programs for children, the elderly and youth.

The Young Children Basic Gymnastics Promotion Council from China was very active in promoting basic gymnastics activities for young children.

ISCA Asia is also planning and soliciting for sponsors to conduct Open Invitational Badminton Championships in Kuala Lumpur in August, 2009.

The ISCA Asia held its General Assembly for the year 2007 on October 25, 2007 in Kuala Lumpur. A total of 23 representatives from 8 countries in Asia participated in the General Assembly.

In general ISCA Asian members would like ISCA to create more activities and programs for youth, elderly and children. ISCA should also provide funds for our members to organize activities among Asian members and for sports and cultural exchange with members from other continents.







ISCA has been invited to present a paper in the 1st Fitness Conference from June 19⁻21, 2009 which is organized by the National Association for Fitness Instructors of Malaysia.

The President and Vice President of the Young Children Basic Gymnastics Promotion Council, Beijing represented the President of ISCA at a reception hosted by the European Commission to China and Mongolia and the European Para Olympic Committee on September 8, 2008 in Beijing.

Professor Lee Jong-Young from ISCA Korea participated in the meeting of the Working Group on Sports and Culture and meeting of CIGEPS Round Table Strategies to improve the visibility of Traditional Sports and Games on 27th September 2008 in Busan, Republic of Korea.

In 2009, ISCA Asia would like to promote its activities for youth and seniors in Vietnam and India where there is a great demand and interest for these activities.

Dance and Folklore Committee

In 2007-2008 we worked to consolidate our efforts to generate strategic alliances in the promotion of this committee. For this purpose two events have been organized in Colombia:

An agreement of alliance was reached in 2007 between SESC, (Mr. Danilo Santo); COMPENSAR, (Guillermo Gonzalez); the Foundation Recreation and Sport for All, (Liliana Ortiz); ISCA (Anders Bulow); and the Walk and Bike Foundation of Canada. We acquired the commitment to develop joint activities to promote the knowledge of the different cultural expressions and the tradition from the respective countries, through dance, choreography, music and the sport, teaching values that help to form better citizens.

Our 2nd event was organized in August 2008 in the city of Bogota: the First International Dance and Folklore ISCA Festival within the Summer Festival of Bogota with massive attendance during the two weeks including approximately one million persons.

13 presentations in different scenes were made in name of ISCA, free for the public. We had representation groups from Brazil, Denmark and Colombia. Colorful choreographies and exhibitions with Brazilian flavor and joy. A part of Danish culture was also on display and was admired for its elegance, spectacular jumps, exact movements and great flexibility and harmony. The Colombians were united to the intercultural celebration with their own representation, a salsa group that showed flavor and elegance of one of the greater cultural expressions of Colombia. The presentations were accompanied with music adapted specially for each performance of the activities. With expressions of gestural theater, circus and other cultural manifestations, where the art and the creativity were always present. The participating organizations thanked ISCA for the opportunity to offer the citizens of Bogota and participants in the Summer Festival an international show of a very high quality.

ISCA now has new promoters. More than 20,000 Colombians went to see the shows. Colombia also has new ambassadors from Brazil and Denmark.

About our coming events: in February 2009 we are planning a city tour to Bogota. The Danish National Performance Team will visit in March 2009. In August 2009 we aim to have 5 or 6 different groups from Europe and Asia in the Second International ISCA Dance and Folklore Event.

ISCA invites all members to participate in international cooperation on topics of special interest for each member. The goals are that national organisations should benefit from being part of inspirational and developing partnerships.

To facilitate this inspiration, knowledge-sharing and international cooperation, ISCA establishes "Networks" of organisations with similar interest. Through these thematic "Networks" all members have the opportunity to join into cooperation on topics, which have their special interest.

How is an ISCA Network developed?

It is important for ISCA that the interest and challenges of the members are supported. Basically, it means that if a group of members have a common interest in a specific topic, ISCA encourage the members to establish a Network. The development of and ISCA Network is very simple and follow the steps described below:

- Step 1.Identify area/topic of importanceTypically done by Executive Committee, Continental Committees or members
- Step 2. Create a position paper to describe and motivate The position paper represents the opinion of ISCA and has to be approved by the Executive Committee
- Step 3. Identify the preliminary interest from members /sector. This is to test the amount interest of the identified topic among the members. If this "test" is satisfactory, the Executive Committee can suggest to make an ISCA Network. If not the position paper is the final step.
- Step 4. Create and run an ISCA Network An ISCA Network is an open network for organisations with interest in the Network topic. The primary objectives of the Network are to develop new knowledge, cooperation and partnership. The Network is lead by one or more organisations (Network Leaders). The Network can operate and organise its work in the way the network participants find it most appropriate to reach its goals. The Network Leaders refers to the Executive Committee.

ISCA Report on Youth Activity

The Year of YOURCE

2007 was a year of intense focus upon new directions in ISCA youth work. While ISCA remains committed to activities and events for young people, we were able to realize more permanent and sustainable development in our youth work. This sustainability is being realized through the development of YOURCE – an on-line platform for community by and for young people.

Conference

16-21 October, Copenhagen

The Conference "YOURCE - Open Source Youth Networking" was a successful attempt at providing networking opportunities for the "next" generation of youth and of linking European NGOs with stakeholders of the modern development of Web 2.0 and open source.

The YOURCE network combines the basic need of individual inclusion with modern approaches to information exchange (i.e open source and web 2.0 technologies). The goal is to provide the most "open" and accessible youth network for the greatest number of







participants.

The conference brought together over 50 actors within the network, organizations engaging for the network and external stakeholders and experts contributing to the network.

Long-term International Youth Leader Education (IYLE) Ollerup Academy of Physical Education

ISCA maintains a close cooperation with the Ollerup Academy of Physcial Education. This cooperation provides the opportunity for international students to attend one or more semesters via tuition scholarships. ISCA actively recruits and refers students who wish to study in the spring and/or fall semesters. The 2008 international profile included 30 young people from 14 countries in Europe, Latin America and Asia.

Youth Workers at ISCA Secretariat

ISCA has a strong tradition of hosting young European volunteers at the Secretariat in Copenhagen. These volunteers have the opportunity to assist in youth project development and implementation. In 2007 we have hosted Tobias Martens (Germany), Saara-Sofia Suttela (Finland) and Karine Teow (United Kingdom) through the European Voluntary Service. In 2008 we have hosted Antonio Saccone (Italy), Jiri Panek (Czech Republic) and Nela Kralova (Czech Republic.) These volunteers have contributed greatly to ISCA's youth work.

ISCA Expands Role with European Voluntary Service (EVS)

Following many years of hosting EVS participants, ISCA has expanded its relation to the EVS program by becoming an EVS Coordinator in Denmark. This new status will allow ISCA to utilize its vast contacts with youth and more specifically, coordinate EVS hosting for sport related organizations in Denmark.

EYSF2008 Preparations

The European Youth and Sport Forum, first conceived by ISCA in 2001, has grown to be an annual event that delivers an innovative and politically relevant opportunity for the youth of Europe. The ongoing partnership of organizing EYSF has also expanded. Consequently, preparation with organizing partners, local hosts and the steering group is necessary one year in advance of actual event. The first prep meeting for EYSF2008 was taking place in December 2007 in Paris. The EYSF dates are 30 November-6 December 2008 and the forum will be held in Paris. Over 315 applications were received for 100 positions!







VIVICITTÁ Youth Training

On 21-25 May 2008 twenty-four young Europeans from ten different countries met each other in Bucharest to undergo a training course linked to Vivicittá, a non-competitive running event, which takes place simultaneously in 60 different cities all over the world. Vivicitta is a social run that is linked to social topics and social messages.

Born from the cooperation between ISCA and UISP (Italian Sport for All Association, ISCA member) and with the support of the European Youth Foundation of the Council of Europe, the training had two goals: to spread the concept of Vivicittá and to involve the young participants and their organizations in the Vivicittá network for the coming editions of the run. The training has proved successful as participants have begun making plans to implement Vivicittá in their communities in 2009!

SEEYOU Training Seminar

South East European Youth Leader Training Trough Sport

- 22-28 September 2008, Tivat, Montenegro
- ISCA in cooperation with "Montenegro Sport for All Association"
- 25 young people gathered in Montenegro for the SEEYOU Training.

Project Summary

The main themes of the SEEYOU training seminar were intercultural dialogue and democratic development through grassroot sport. The objective was to offer non-formal education training to young persons of Balkan youth and sports organizations in order to assist with democratic development of ethnically diverse local clubs and associations.

The training methodology was based upon open space technology, which has been used by ISCA at previous EYF support trainings and seminars. The program was focussed on two main issues that have been identified as important to youth in the region. The first one was intercultural dialogue and the second one was democratic development.

In 2005-2007 ISCA implemented a project for sport organizations entitled Democratic Development Through Grassroot Sport in the Balkans. This project targetted organizational leaders, and not particularly youth. The evaluation of this project identified the need to provide specific training opportunities for youth of the Balkan region with a focus similar to that of our previous project.


REPORT from Latin American Youth Committee (LAYC)



STATUTES

PREAMBLE:

ISCA understands sport as an integral part of cultural life. As people manifest their culture through their specific participation in sport, it is important to promote and to deepen a coherent view of sport and culture.

In the context of Sport and Culture, sport is understood not only as competitive activities and health-related exercises, but also as recreation, pastimes, games and leisure activities.

Sport/Culture is an essential part of education, and a way of educating people to be responsible citizens in their society.

Culture as a way of life includes besides sport and games also traditional customs and festivities, dance, music, song, theatre and other creative and social activities.
